**The Springfield Township Board of Trustees held a meeting Thursday, July 5, 2018 at 6:00 p.m. at the Springfield Township Town Hall, 2459 Canfield Road, Akron, Ohio. Purpose of the meeting: to discuss employment and wages of public employment and then go into Executive Session to discuss the same, and such other matters as may properly come before the Board.**

**The meeting was called to order by Dean Young. Roll Call: Mrs. Davis (here); Mr. Young (here); Mr. DiLauro (here). Warren Price, Administrator was also present.**

**Warren Price: Two seasonal employees that have been assisting at JEDD Park and we need to hire those folks and get those folks paid. We are asking for a motion to hire Logan Hornish and Zach DiLauro as two seasonal employees at a rate of \$11.00 per hour.**

**Dean Young: For our summer employees we normally advertise and seek seasonal employees for our seasonal work.**

**Warren Price: This year we advertised in The Suburbanite and this would have appeared on line. So we advertised for this position. We didn't receive any applications in response to the advertisement, but we did advertise.**

**Dean Young: Not to diminish the qualifications or the work ethics of the guys, because we have seen their work ethics. We did advertise. We did not receive any applications, apparently these two came to us by word of mouth.**

**ADM 132-18      Dean Young: I move to hire Logan Hornish as a part time seasonal summer employee at the rate of \$11.00 per hour effective June 1, 2018. In the past this is at will position and work to be determined by the Township Administrator, and**

should not exceed 30 hours per week. Seconded by Joe DiLauro. Roll Call: Deborah Davis (yes); Dean Young (yes); Joe DiLauro (yes).

**Warren Price:** The next motion would be to hire Zachery DiLauro into that same position at \$11.00 per hour not to exceed 30 hours per week effective June 1, 2018.

**ADM 133-18**      **Dean Young:** I move to hire Zachery DiLauro as a part time seasonal summer employee at the rate of \$11.00 per hour effective June 1, 2018. I think the record should reflect I specifically made inquiries of three individuals and was unable obtain any applicants. One individual was 17 years old and had another job, and have been unable to get any other applications. Motion not seconded.

**Dean Young:** Does this board want to go into recess?

**Joe DiLauro:** I have actually talked to the athletic director and two people didn't come in. We even raised the wage and didn't get anyone. Last year, we had six people and we have no applications this year.

**Dean Young:** I thought I would be able to find applicants.

**Joe DiLauro:** None of the people from last year returned even with a raise.

**Dean Young:** It shouldn't be this difficult. Do we need a moment of reflection?
